- The Institute reserves its right to place a reasonable limit by putting a certain criteria on the total number of candidates to be called for written test / interview.
 - Merely fulfillment of qualifications does not entitle a candidate to be called for test or interview.
 - The Institute reserves the right not to fill up the posts, cancel the Advt. in whole or in part without assigning any reason and its decision in this regard shall be final.
- The Institute follows the reservation norms as per GOI rules for SC/ ST/ OBC/EWS and PwDs. Central Govt. approved list of SC, ST and OBC categories as applicable at IIT Lucknow. Copy of the Category Certificate (OBC/SC/ST/Pwd), issued by the competent authority, not below the rank of a Tahsildar, and must be attached. In case of OBC candidates, the certificate indicating the status regarding creamy layer must be issued on or after 01/01/2019. PwD certificate must have been issued by the competent authority as per Government of India norms.
- Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. - (d) Incomplete application or without relevant supporting enclosures or if received after closing date, i.e. 22nd July 2019 till 05:00 P.M., will be summarily rejected.
- (e) Person serving in Govt./ Semi-Govt. / Autonomous/ PSUs should also apply online and send the print out of completed application form along with all relevant supporting documents and transaction slip with date, duly self attested, **THROUGH PROPER CHANNEL**. However, an advance copy, superscripted as “Advance Copy” on the application form, may be submitted before the last date. Further, the institute may consider relaxation in upper age limit in case of highly experienced and deserving candidate.
